Who Should Install This Software

ETM System v5.0.2 Update 5 is recommended for all customers currently running v5.0.2. Visit <http://support.securelogix.com/updates/index.htm> to obtain the update. It is a cumulative software update that includes all fixes and enhancements issued since Release 5.0.2.

This maintenance release can only be installed on ETM System Software v5.0.2. If you are running a previous version of ETM software, please contact your Account Executive or SecureLogix Customer Support for updated software.

About This Document

This document contains important information about ETM System v5.0.2 Update 5. The ETM System includes the ETM Communications Appliances, ETM Server software, and the ETM applications: the Performance Manager, the Voice Firewall, the Usage Manager, AAA Services for the Voice Firewall, the Voice IPS (Intrusion Prevention System), and the Call Recorder.

Special Configuration Instructions

Additional database privilege may be needed—The ETM System Database User must have the CREATE SNAPSHOT system privilege. If you receive an error message when you attempt to connect to the database via the Database Maintenance Tool during the software update process, log in to the ETM Database as SYSDBA via the Enterprise Manager Console or SQL*Plus and grant the CREATE SNAPSHOT system privilege to the ETM System User.
